



2010 Ontario Winter Games Bell Legacy Fund Criteria

It is the objective of the 2010 Ontario Winter Games Organizing Committee that a fund be established to support amateur sport, to enhance access to amateur sport programs and facilities and to build community capacity in Muskoka.

The Legacy will be funded from the 2010 Ontario Winter Games surplus and it will be administered by the 2010 Ontario Winter Games Bell Legacy Fund Committee (Legacy Committee). The Legacy Committee will also be the group responsible for selection of successful applicants to the Fund. Appendix (B)

The Legacy Fund will be distributed throughout the six Muskoka Municipalities at the same percentage as their municipal contribution to the OWG Appendix (A).

Local groups and athletes are encouraged to apply for funding from the Legacy Fund if their objectives meet the following goals of the Fund. Priority will be given to those who best satisfy the criteria:

1. To increase opportunities for the development of athletes to pursue competitive goals and achieve their personal potential;
2. To develop, promote and enhance amateur sport at the community level;
3. To create opportunity for a local organization to host an event or championship

Funds are not to be used for the general purposes or operating costs of any municipality, including the Host, or of any other third party.

The Legacy Fund Committee will accept applications semi annually.

Spring Applications

Start date: March 4, 2011

Deadline date: May 1, 2011

Fall Applications

Start date: Sept 2, 2011

Deadline date: November 1, 2011.

Applications for assistance will be reviewed by the Committee on these dates and then every 6 months thereafter until the fund is depleted. While applications are accepted in the spring and fall, this does not reflect which season's sports may apply within.

While the Legacy Fund has no set limit on how much funding may be requested, it is important to remember when applying that the Fund must be distributed proportionally among the municipalities of Muskoka and initial amount available within each community is listed in Appendix A.
